Secretaries Holton and Hazel Tout Fairfax Nonprofit That Delivers Quality Preschool to At-Risk Children through Strong Private-Public Partnerships

Fairfax, VA – June 20, 2016 – Virginia Secretary of Education Anne Holton and Virginia Secretary of Health & Human Resources William Hazel toured Main Street Child Development Center (Main Street), a Fairfaxbased nonprofit organization, on Friday, June 17th.

Secretaries Holton and Hazel visited to learn about Main Street's unique model, which delivers high-quality preschool and school age programs, and is supported by a complex network of partnerships and funding streams.

Main Street's guests – both members of Governor Terry McAuliffe's Cabinet – demonstrated particular interest in effective public-private partnerships that generate positive outcomes for children and families.

In addition to Deputy Secretary of Education Holly Coy, staff members from Fairfax County Office for Children and the VPI+ Federal Grant Program accompanied Secretaries Holton and Hazel on the tour. Main Street collaborates with Fairfax County Office for Children in implementing Virginia Preschool Initiative (VPI) and Child Care Assistance and Referral (CCAR) programs, both designed to provide quality preschool experiences for at-risk children.
